Be Prepared: Hundreds of Voters Lost Their Votes in 2014 Primary Due to New Election Rules

Democracy North Carolina and others are assembling today, exactly one month before the deadline to register to vote, to highlight the hard realities under the state's new election rules. Our overall message is: You can still vote, but it's important to be prepared because many honest voters are already being turned away at the polls and harmed by the new election laws.

We analyzed the provisional ballots cast in the 2014 primary by more than 400 voters whose votes would have counted in 2012, but who were rejected this year because of two changes in the rules: (1) these voters were unable to register during the Early Voting period because they couldn't use the old "same-day registration" law; or (2) they were unable to cast a ballot on Election Day outside of their own polling place because they couldn't use the old "out-of-precinct voting" law.

Voters denied a chance to have their voices heard include a veteran returning from Afghanistan whose registration was incorrectly terminated while he was away; a first-time voter who registered at the DMV, but that registration didn't reach the local board of elections; a precinct judge assigned to a precinct other than her own who couldn't leave to vote in her home precinct; a disabled senior who was driven to a friend's polling place on Election Day; a nurse who temporarily registered her car in a nearby county while working at its hospital for nine months; a college student who registered during a voter drive but her application was not recorded; and a new couple in town who mailed in their registration but it did not reach the county board of elections before the registration deadline.

The voters who cast the 454 rejected provisional ballots come from every walk of life, and are of all parties, races, and age groups. But their composition is startling because it reveals that the new rules are indeed affecting African Americans and other people of color much more than white voters, and Democrats more than Republicans.

While Black voters make up 22% of all registered voters, they were 39% of those who lost their votes because of the two rule changes – the elimination of same-day registration and elimination of out-of-precinct voting on Election Day.

Democrats are 42% of the state's registered voters, but 57% of those disenfranchised by the new rules.

These 454 voters are obviously just the tip of the iceberg of the thousands who faced the same problems when they went to vote in the primary and who simply left the polling place without taking the time to fill out the paperwork and file a provisional ballot.

These voters learned the lesson about the new election rules the hard way.

We are urging all voters to learn the lesson before it's too late. We are now one month away from a big deadline – the deadline to register or update your registration to your current address. Our advice is to use these next 30 days to prepare for the fall election.

Number 1: Make sure you are registered to vote at your current address. The October 10 deadline is a firm and final deadline – there's no more Same-Day Registration. Go to NCVoter.org and check out your registration status. You can also look at your sample ballot at the same time.

Number 2: The best time to vote is during Early Voting because if you have problems, in many cases they can be fixed but if you wait until Election Day and discover a problem, it could be too late.

Number 3: If you wait until Election Day, then you must vote in your home precinct's polling place, which may not be the one nearest to where you work or where you voted in the past.

Remember: You can still vote, but like other important events, it's best to be prepared. Honest voters are already being harmed by the new rules. Don't let it happen to you. Stand up for your rights, vote!

STORIES OF DENIED VOTERS FROM MAY PRIMARY

** Mark Perry of Franklin County went to early vote and was told he was not registered. He's never voted before but when he applied for a driver's license, he told the DMV examiner that he wanted to register, using the "motor voter" system in place for over 20 years. However, as is well known in election administration circles, a voter registration done at DMV does not always make it into the election system. Under the old law, Mr. Perry could have used the back-up of same-day registration; he could have registered at the Early Voting site and received a ballot to vote. Instead, he lost his chance to vote in the primary because that protection to help voters has been eliminated.

** Craig Thomas of Granville County was surprised to hear that he was not registered to vote even though he was before he left to serve with the U.S. Army in Afghanistan for 18 months. He went to an Early Voting site on April 30 and was told there was "no record of registration" for him, even though he returned to the same house in the same precinct after his deployment and he was never notified that his registration was being cancelled. Under the old law, Mr. Thomas could have used same-day registration to register at the Early Voting site and vote. Instead, he had to use a provisional ballot and it was not counted. He lost his chance to vote in the primary because of changes in the law.

** Ashley Gragg of Yancey County works as an assistant judge on Election Day at a polling place that is not her own precinct. Because she was on vacation during Early Voting, she needed to vote on Election Day but you can't leave your assigned polling place if you serve as a judge for the board of elections. In an effort to have her vote counted, she filled out a provisional ballot at the poll where she was working, but had a feeling it would not count under the new law. She was right. She lost her vote because out-of-precinct voting is no longer allowed on Election Day.

** Gillian McNamara, a high school student in Harnett County, was encouraged by her history teacher to work inside the polls as an elections assistant. She knew that as a 17 year old who would turn 18 in October that she had a right to vote in the primary. But she was unable to leave her station and wound up casting a provisional ballot where she was working. She thought her ballot would count, but it didn't. It was a hard lesson to learn as a new voter – but she hopes to work at the polls again. .

** Malcolm Cameron is 71 and a life-long resident of Harnett County, in the town named for his family. His wife passed away a few years ago and he now lives by himself with his dog. He is disabled with a bad back and rarely drives. A friend from church took him to vote but took him to the friend's polling place. He was told he couldn't vote there except with a provisional ballot. He thought it would count, but it did not because he was voting on Election Day outside of his home precinct.

** Anita Buck is a nurse in Carteret County. She traveled to Cumberland County to help at a hospital there for nine months and updated her driver's license there. She moved back to her home in Carteret County, but didn't realize her voter registration had been changed until she went to vote in the primary. She was told her name was no longer on the rolls. Without same-day registration, she was out of luck. She voted with a provisional ballot, which re-registered her but the ballot did not count. "I've been voting since I was 18, so I know the duty of it," she said. "I went and did it; and the good news is, I can vote this November, but I had no clue that it [the new law] affected me."

** Jotoya Williams is a freshman at Fayetteville State University and returns home frequently to Laurinburg. She registered last spring as a high school senior in her hometown. Unfortunately, the registration application she filled out during a drive at the school did not reach the Scotland County Board of Elections, so Ms. Williams was not on the rolls. She voted with her parents and sister but her vote did not count.

** Henry Wiggins of Harnett County knew that his voting rights returned to him after he recently finished serving his felony sentence but he didn't realize he had to register all over again. He went during Early Voting and under the old law he could have registered right then, but without same-day registration, he was stuck with a provisional ballot that did not count.

** Amy Borders, Pender County, a mother and loyal Republican voter, voted on Election Day but she cast a provisional ballot because her name did not appear on the registration rolls where she voted. She had moved from one precinct to another part of the county. The county board of elections sent her a notice that the postal service indicated she had a change of address, but the board needed her approval before it could change her registration to the new address. Ms. Borders didn't return the notice, and she voted in a precinct that was neither her old one nor new one; her provisional ballot was not counted.

** Paris Drew has voted in her home in Columbus County, but when she went to UNC Pembroke, her registration mysteriously was terminated. The officials at the polls could not understand why the change happened and gave her a provisional ballot. With same-day registration, she could have begun all over; she is now properly registered but her provisional ballot was denied in the 2014 primary.

** Henry and Jeraldnette Simmons moved to Granville County in February 2014 from Durham where they were regular voters. They filled out a new registration form but the local board of elections said it was not received so they had to vote provisional ballots in the primary – which were not counted.
