2021 was the year of the decennial census and therefore redistricting took place at local, state and federal levels. Democracy NC played a critical role in keeping the public informed of the process, collaborating with partner organizations to urge the legislature to conduct an open and fair redistricting process, and documenting public hearings to provide evidence in litigation against the unfair maps.

4b (Code: ) (Expenses \$ 574,914. including grants of \$ ) (Revenue \$ )

Democracy NC provided education to the public regarding the municipal elections that would take place in 2021 and those that were delayed to 2022 due to the late census. We wrote, printed and distributed 120,000 nonpartisan voter guides to the public with information specific to their municipalities' polling dates, times and location as well as a description of the candidates running in their localities.

2021 was a year of a long session of the legislature. The legislature did not complete its session until March of 2022. During the long session, Democracy NC keeps track of bills that come out of either house in the NCGA to evaluate their potential impact on citizens, particularly those that either improve or suppress voting rights and access. At least a dozen bills in many iterations were considered that would hamper citizens ability to vote. Democracy NC's Communications, Advocacy and Organizing departments worked to ensure those bills would not ultimately pass.
